Payment. Fees. & Gratuity

The final payment(s) for the services provided are due one week prior to your wedding day by credit card or cash. Checks are not accepted.

Please see the "Travel Guide" section for our pricing/fees and policies regarding travel. There is a minimum of 6 contracted services when traveling for on location services.

Gratuity is not included in the provided pricing but will be applied in your final payment.

Contract Changes

Any changes after the contract is signed must be submitted 30 days prior to your contracted date. Charges for quest(s) requiring additional services must be paid in full prior to the day of the service.

Cancellations

Cancellations of services within or the entirety of the contract require 30 days' notice prior to the service date. It cancellations are made past the 30 days' notice, you will be responsible for paying 100% of the total of the contracted services and deposits will not be refunded. If cancellations are made prior to the necessary 30-day notice, you will receive a full refund of your initial deposit.

Late Herivals

If the bride and/or a bridal party member is late on the day of the services, a \$20 fee will be applied to the individual(s). Any arrivals past 30 minutes after the scheduled service may result in an incomplete service without refund.
